






Fig.4b SURREY and MERTON

Additional comments:

Age-related

- None of the respondents collects data about age of members
- Impression that more men joining in early 60s than older men (SE London)
- Two distinct times in life when people join: retirement and death of partner (SE London)
- If men are joining later in life, that may explain smaller numbers and lower levels of participation (Merton)
- Women live longer than men (Hackney; Croydon)

Work/retirement

• Many men are still working/ working part-time/working beyond retirement (Beckenham; Hackney; Merton)

Marital status

- Many more widows join and live longer (SE London; Croydon)
- 70% men join as a couple (Orpington)
- Majority of members are single women (S. Hillingdon)
- Couples retire away from London, but singles (mainly women) stay close to friends, including U3A (Croydon)
- Men often don't feel the need to join any organisation until they find themselves without a partner

Psycho-social issues

- Men put off by preponderance of women; comments about "queen bees" (SE London; Merton)
- U3A seen as an organisation for older people (can be off-putting to younger men and women) (SE London)
- Men's friends tend to be workmates/women have wider circle of acquaintances (SE London)
- Men are not such compulsive joiners, and either do not need -- or do not want to seem to need -- the same social contact as women (i.e. with lots of chatter!).

Venue

- Freedom Pass in London means cars not needed so women can be independent/not reliant on male driver;
- Men don't use buses as much as women (Croydon)
- Some men prefer to socialise over a drink at the pub. Some men prefer to potter at home and not commit to anything.

Learning

 Men prefer to study more seriously/formally with people at similar level, rather than enjoying mixed abilities (SE London)

Publicity

- Aware of discrepancy but no particular effort to attract men (Bromley)
- Men might join in greater numbers if the marketing were correctly aimed (Merton)
- People often join by word of mouth/women more likely to recruit friends than men are (SE London)
- Male members not particularly enthusiastic about increasing male membership (confidential)






4.2 OFQUAL National Qualifications Framework



Proportion of the UK population over 55yrs that is economically active: by age group and $sex^{1,2}$, April to June 2011










1.3. EMPLOYMENT IN MERTON – OCCUPATIONS


People Aged 16-74: Higher Managerial and Professional Occupations






People Aged 16-74: Lower Managerial and Professional Occupations






People Aged 16-74: Semi-Routine Occupations

People Aged 16-74: Routine Occupations














2.4. DEPRIVATION GREATER LONDON BOROUGHS

2.5. MIGRATION from London to Regions in England and Wales, Mid-2011












4.2. SURREY PERCENTAGE OF POPULATION AGED 65+years 2011






4.4. SURREY DIVERSITY


4.4.1. % of NON-WHITE PEOPLE (Total population)






4.5.1. % ALL POPULATION: Higher education (Level 4+)



4.5.2. % ALL POPULATION: Level 3 (A-level or Diploma)




4.5.3. % ALL POPULATION: No qualifications






